Specific hazards arising from the chemical:

In case of fire, carbon monoxide and carbon dioxide may be formed. Acute overexposure to the products of combustion may result in irritation of the respiratory tract. Measurements at temperatures above 150°C in presence of air (oxygen) have shown that small amounts of formaldehyde are formed due to oxidative degradation. This product may generate the flammable gas (hydrogen) when exposed to acidic or basic water and will intensify the fire, or possibly explode if confined in a container.

If contamination occurs, pressure build up caused by hydrogen gas generation in sealed containers can cause bulging, rupture, or even violent explosion.

Special protective equipment and precautions for firefighters

Special fire fighting procedures:

Keep away from sources of ignition - No smoking. All equipment used when handling the product must be grounded.

Special protective equipment for fire-fighters:


